



CCEI is committed to excellence in chiropractic education and has developed the *International Framework for Chiropractic Education and Accreditation* as an instrument to determine the equivalence of programs in areas of the world with different educational systems. Among other roles, it also assists in the development and recognition of new accrediting bodies in geographic regions where such agencies are not currently recognized.

Annual Meeting

CCEI met at Berlin, Germany on March 23-24 2019 in conjunction with the Annual meetings of the International Chiropractic Regulatory Society (ICRS) and World Federation of Chiropractic (WFC) and European Chiropractors' Union (ECU) Congress. The Annual meeting is the one-time each year that the representatives of the CCEs from Australasia, Canada, and Europe meet face to face to learn of each other's activities, greet new members, review committee reports, and present and discuss progress on projects in process.

Budget

The Board approved its annual budget for 2019. The 2018 financials show a small surplus. CCEI is focused on functioning efficiently while also continuing to be fiscally responsible. CCEI considers the cost of new activities that would require additional spending very seriously.

Mapping Project

With some agencies having revised their standards recently, a process is underway to ensure the maintenance of equivalence of standards internationally. Member agency standards should meet or exceed those described in the *International Framework for Chiropractic Education and Accreditation*. There are three mapping documents: Standards, Competencies, and Procedures of Accreditation. The mapping documents have now been completed by the member agencies and these will be reviewed in accordance with CCEI policy.
